Community Description and Demographics

Located in north central Dickinson County, Sagola Township’s land area includes approximately 104,359 acres inhabited by 1026 people. Most of the land area is forested, approximately 83.4%, while residential development is concentrated in the communities of Randville, Sagola, and Channing.

Understanding an area’s population trends helps evaluate a community’s existing and future needs. These statistics will assist Sagola Township in determining the direction of local capital improvements and related expenditures for recreation planning. They are also a useful tool in creating recreation guidelines for the Township.

Utilizing demographic information such as population, age distribution, and income level in the planning process helps guide how to best create and maintain recreational facilities and programs for Sagola Township residents.

Recreation Administrative Structure

The Sagola Township Recreation Advisory Committee is tasked with recommending ways to best meet the recreational needs of the community. The Recreation Advisory Committee is an advisory committee that reports to the Township Board, which is responsible for the provision and administration of local recreation opportunities in Sagola Township. The Township Board has the authority to commit funds for parks and recreation, accept grants and purchase land on behalf of the community.

The Township Board includes funding for ongoing maintenance and operation of recreational facilities in the annual General Fund budget. Expenditures are offset from the revenue generated from the campground fees at Newberg Park, and rental fees at Township buildings. Funding for capital improvement projects is appropriated when funding sources have been identified or available.

Volunteers/Community Relationships

Sagola Township provides and maintains recreational facilities for users but does not provide programming. The volunteer recreational uses that require organizing and scheduling are guided by a program of community enrichment that allows such programming to be done with no usage fee for facilitates. Township officials maintain an oversight role to ensure equitable usage among various groups with scheduling conflicts addressed by the Township board. All facility use needs to be prescheduled. See township website for scheduling information.

The Township has also benefited from relationships with the volunteer fire department, Sagola Township Community Enrichment, local businesses, and church and youth groups. These groups have either contributed time during the township park clean-up day, skills for labor intensive projects, and/or donation of supplies. The Township has had a long and successful relationship with various community organizations and is interested in expanding and strengthening these partnerships.

Sagola Township Recreation Sites

Members of the Recreational Advisory Committee conducted an inventory of the Township’s recreational sites. Sites were evaluated visually and updated information was incorporated into the plan. The Township owned facilities were evaluated for accessibility and determined the facilities are in need of updates to improve the accessibility for all users; accessibility improvements are included as objectives in this plan. The following rating scale was used:

- 1 = none of the facilities/park areas meet accessibility guidelines
- 2 = some of the facilities/park areas meet accessibility guidelines
- 3 = most of the facilities/park areas meet accessibility guidelines
- 4 = the entire park meets accessibility guidelines
- 5 = the entire park was developed/renovated using the principals of universal design

Sagola Township Community Building (3 Acres)

The Township’s new 8,100 square-foot community building was built in 2017, and is located in Sagola, along M69, at 300 First Street. The construction incorporated universal design features to ensure accessibility. The Sagola Township Board and other boards and committees use the building for regular meetings. The Community Building and pavilion are available for rent; see current rates on the Sagola Township Website: sagolatwp.com

A new playground was added in 2023, including a playscape, swings, bouncy rides and climbing structure. This provides facilities for children ages 2 to 12 years of age.

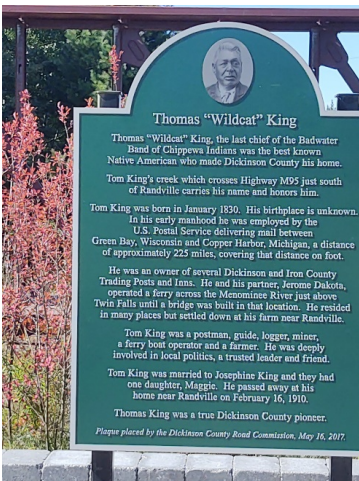

Randville Hall

Randville Hall is located on M95, between Sagola and Iron Mountain. The hall is used a venue and community space by township residents, and is available for rent. A small memorial on the site remembers Dickinson County pioneer Tom King, an influential entrepreneur in the community.

Newberg Park (25 acres)

Newberg Park is located on Sawyer Lake in the northern portion of the Township. The facility provides camping, picnicking, a swimming beach, playground equipment, public boat launch, fishing, and boating. The park is nearly 25 acres in size and has 1,400 feet of lake frontage. There are 30 camping sites at Newberg Park and a pavilion that can be reserved for private events. Current rental rates are on Sagola Township Website: sagolatwp.com.

The Township reviews the revenue and expenditure annually to ensure proper maintenance and management of the park.

Channing Athletic Complex

The Channing Athletic Complex is located in Channing on East Avenue between 2nd and 3rd Streets. The facilities at the complex include a pavilion with electricity, picnic tables, two baseball fields, playground equipment, tennis courts and bathrooms. The Complex is utilized for baseball games and practices.

The Township’s annual Independence Day festivities are usually held at the Complex on the Saturday before July 4th. They include a parade down M-95 ending at the Athletic Complex where there are games for children and adults, music, food and beverages, bingo, corn-hole tournament, and fireworks. The Sagola Township Volunteer Fire Department spearheads this event with help from the Sportsmen's Club, Sagola Township Enrichment Committee, and others from the community.

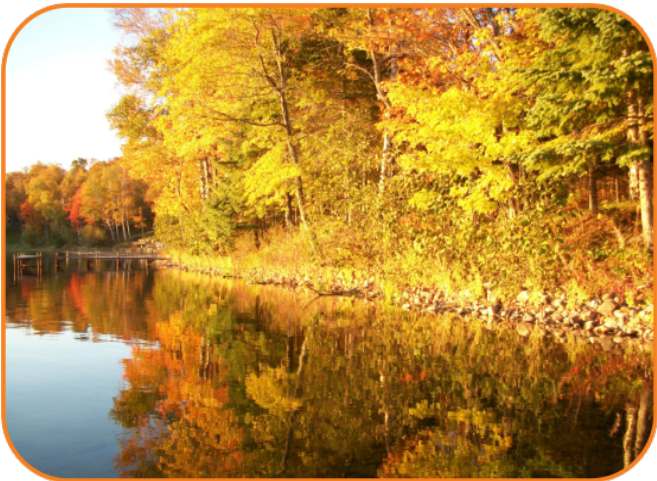
Camp Molinare at Sawyer Lake

Camp Molinare is located just 25 miles north of Iron Mountain on Sawyer Lake. The Camp is owned by Camp Molinare board, who hosts summer camps and educational events at the site. The camp is also available to rent as a venue for the general public. It offers two dormitory style bunk houses (sleeps 40 total), each with their own bathrooms and showers. There is a full kitchen and dining hall connecting the dorms, which includes tables/benches, cookware/dinnerware, gas range and a convection oven. There are three additional cabins on site which also have showers and bathrooms. The Camp has access to swimming, canoeing, hiking, outdoor sports and recreation, campfires and ATV trials. Edey Lake

The lake is 79 acres which is located four miles northwest of Channing just off Sawyer Lake Road. The boat launch is a hard-surfaced ramp where launching and retrieving of large boats may be difficult and not recommended. Five parking spaces are available at the access, along with a rustic outhouse. This site is operated by Department of Natural Resources.



The Sportsman's Club

The Sagola Township Sportsman's Club is located on Edey Lake. The club was founded in the 1940's, its current membership stands at 200. The club encompasses 40 acres which includes a beautiful log clubhouse, an outdoor pavilion, a trap range, sporting clays range, 100 yard rifle range, and archery range. Every spring the members conduct a Hunters Safety Class and field day for area youth and any Michigan resident free of charge. The 4H Big Shooters meet, and hold their monthly shoots here. The club is available for rent for weddings, graduation parties, private functions, and seminars.

This facility meets most of the accessibility guidelines.

Silver Lake

Silver Lake Resort is a full-hookup RV campground located on State Highway M-95, five miles north of Channing. This is a private campground with 30 sites. Silver Lake Resort Restaurant and Store serves a wide variety of foods and beverages. They also offer DNR hunting, fishing and ATV/ORV licenses.

Public lake access is available with a boat ramp on the North end of Silver Lake located west off Highway M95. This site is operated by Department of Natural Resources.



Race Landing

Race landing is located just over four miles northwest of Channing and provides access to the Michigamme River. Facilities include a boat launch and vault toilet; it is operated by WE Energies. Directions to the site follow Sawyer Lake Road approximately two miles north of Channing and turn left at Race Road, follow the road for another two miles to the end.

Library

Sagola Township has two "Little Free Libraries" with children's and adult books available to be taken by anyone. People are free to leave a book, or return the one they borrowed; but they are not required to do so. The two locations are: N12846 Sawyer Lake Road and at the North 95 Welcome Center next to the Channing Post office.

Grant History

The Township Board and Recreational Advisory Committee have identified that additional funding through grants offered by the DNR is needed to support planned upgrades and amenities at Newberg Park. These projects are outline in the action plan below.

Planning Process

The Sagola Township portion of the Recreation Plan was updated to correspond with the changing recreation needs of the area. The Sagola Township Recreation Advisory Committee was instrumental in preparing this plan and initiated the update. Committee members evaluated current recreation facilities, and to reached out to those that utilize recreational parks and facilities through a public survey. The survey was available online through web site and was available in print form at the Township Hall, Channing and Sagola post offices, church, public events and Senior Center. 47 surveys were completed. The survey feedback showed that 62% of residents feel that the Township's recreational facilities and programs are important to the community. Nearly half of respondents were neutral in their assessment of Township recreational facilities, indicating that there may be additional room for improvement. 46% of township residents would support funding additional improvements through a tax increase or other funding method.

Survey of Township residents:

A survey was made available to the Township residents. The results of the survey are as follows:

30% of residents use the recreational facilities monthly, 21% weekly.

Hiking, fishing, boating and swimming were what most residents participated in.

45% of residents were neutral on satisfaction of current recreational facilities with 30% satisfied.

62% of residents felt recreational facilities and programs were important or very important to the community.

45% of residents do not feel there are enough recreational opportunities for different age groups.

46% of residents agreed to pay for additional recreational programs or facilities through tax increase or other funding.

79% of residents heard about activities through word of mouth.

A copy of the completed survey with results can be found in Appendix A.

For a period of thirty days, the proposed Recreation Plan is available for review and comments by contacting the township board at a regularly scheduled board meeting. The proposed Plan is also on Sagola Township's website (sagolatwp.com). This comment period is from December 1, 2023, and ending on December 31, 2023. The comment period was advertised in the Iron Mountain Daily News on December 1, 2023. No public comments received.

The Sagola Township Board held a Public Hearing on the proposed Sagola Township Recreation Plan on March 4th, 2024. No public comments were received at this Public Hearing. The public hearing was noticed in the Iron Mountain Daily News in February 17th, 2024 and a notice was available at the Township Hall and on the website.

The Sagola Township Board adopted the Recreation Plan by resolution at its regular meeting held on March 4th, 2024. A copy of public meeting minutes and the resolution are available in Appendix B and C.

Goals and Objectives

The objectives identified in this plan help guide recreation related decision-making. Consideration of the recreational policies should lead the community toward the attainment of its goals. The following goals and objectives should serve as guideline toward development strategies.

Maximize use of recreational opportunities offered by the area's natural environment while also placing an emphasis on maintenance and continuous improvement of facilities.

Objectives:

- *Facilities should be designed to complement the surrounding natural quality of the area.
- *Whenever possible, the Township and private interests should coordinate the development of recreation facilities and programs.
- *Proper maintenance should be ensured for all facilities.
- *When suitable, existing facilities should be repaired before new ones are built.
- *The Township and concerned organizations and individuals should develop programs and incorporate designs to reduce vandalism.
- *Bring all township facilities up to Americans with Disabilities Act compliance.

Basis for Objectives:

Maintenance and continuous improvement of facilities and parks is a most widely supported priority. Complementing the surrounding natural quality of the area is an important aspect in creating recreational spaces that are valued by residents and visitors. Ensuring that recreational facilities are safe is a priority and efforts to reduce vandalism and enhance visitor experience.

We aim to provide a wide variety of recreational opportunities to all residents and visitors of Sagola Township.

- *Projects should be easily accessible to all residents and visitors.
- *Whenever possible, facilities should be for multiple and/or year-round use.
- *Develop and maintain trails and pathways
- *When appropriate, amenities such as restrooms, night lighting, and electrical power should be incorporated.

Action Program

The recreation development schedule reflects a number of valuable recreation projects to enhance the quality of life for all demographic groups. Projects reflect the needs of the community as expressed through public input and under the guidance of the Sagola Township Recreation Advisory Committee. These projects were selected in accordance with the identified goals and objectives.

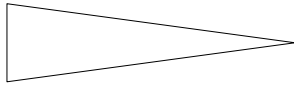



WHEREAS, the Sagola Township Board has developed the plan as a guideline for improving recreation for the Township of Sagola, and


